

### 988 and Crisis Services

- Increase diverse and <u>sustainable</u> funding and support for the full continuum of crisis response, including:
  - Someone to call (crisis call centers)
  - Someone to respond (mobile crisis teams)
  - Somewhere to go (crisis stabilization centers)



## Children, Teens, and Young Adults

- Implement and support comprehensive <u>K-12</u> school mental health and suicide prevention, intervention, and postvention initiatives and policies, including requirements for:
  - Personnel training
  - Student education
  - Caregiver education
  - Excused mental health absences



## Children, Teens, and Young Adults

- Require <u>higher education</u> policies and procedures to:
  - Include how to support students experiencing a behavioral health condition or suicidal crisis
  - Require schools to make policies and related resources widely known and available to all students, faculty, and staff



# First Responders, Corrections Staff, & Frontline Healthcare Workers

- Identify PTSD/PTSI as a compensable, work-related injury
- Extend eligibility for life insurance benefits to families of those who die by suicide
- Establish Employee Assistance, peer-support, and training programs
- Provide privacy protections



#### State Infrastructure

- Increase funding for and assist in the implementation and evaluation of state suicide prevention initiatives and plans to prevent suicide across the lifespan
