New Hampshire SB 357: Relative to mental health training for first responders.

Washington Chapter 18.71B RCW Interstate Medical Licensure Compact

Washington RCW 18.130.340 Opiate Therapy Guidelines.

Minnesota SF 1303 - relating to health; requiring issuance of a grant to support a stillbirth prevention

Massachusetts H. 318 An Act Related to Toxic Free Kids

Iowa Senate File 2159 - An Act relating to insurance coverage for biomarker testing

South Dakota HB 1098 provide free birth certificates to persons experiencing homelessness.

South Dakota HB 1131 - waive certain fees for nondriver identification cards for individuals who are homeless

Pennsylvania HB 1001 - An Act regulating milk banks that provide donor human milk in this Commonwealth.

Maryland HB 102 - Requiring a rear passenger on a motorcycle to be able to firmly position the passenger's feet on the footrests of the motorcycle, subject to an exception for permanent physical disability.

South Carolina (A141, R146, H3200) - An act to amend the code of laws of south carolina, 1976, to enact the "South Carolina Lactation Support Act" by adding section 41-1-130 so as to provide necessary definitions, to provide employers daily shall provide employees with reasonable unpaid break time or shall permit employees to use paid break time or meal time to express breast milk

Missouri SB 1374 - This act establishes "Bentley and Mason's Law". Under this act, if a person is convicted of the offense of driving while intoxicated and such offense caused the death of a parent or guardian, such person shall pay, pursuant to a court order, a monthly restitution to the child of the deceased parent or guardian until the child reaches 18 years of age.

Illinois SB 2658 - Newborn Screening-Duchenne Muscular Dystrophy

Illinois SB 2684 - Amends the Medical Assistance Article of the Illinois Public Aid Code. Requires the Department of Healthcare and Family Services to adopt rules permitting reimbursement under the fee-for-service and managed care medical assistance programs for remote ultrasound procedures and remote fetal nonstress tests

Maryland HB 141 - AN ACT concerning Maryland Department of Health – Residential Service Agencies – Training Requirements relating to dementia

Minnesota, SF 999 - Installation requirement of adult-size changing facilities in restrooms accessible to public

Minnesota SF4058 - Commissioner of human services authorization to provide separate reimbursement for biological products provided in the inpatient hospital setting as part of cell or gene therapy to treat rare diseases

Washington HB 1012 - Addressing the response to extreme weather events.

Washington HB 2057 - Creating a pilot project to assist incarcerated veterans' transition to civilian life.

Alabama Houston Hunter Bill - addresses mental health safety through firearms storage proposal

Maryland SB 1076 - Requiring the Comptroller to distribute to the Transportation Trust Fund revenue from the sales and use tax that is attributable to the sale of electricity used to charge an electric vehicle at an electric vehicle charging station or used to charge an electric vehicle and is not sold under a residential or domestic rate schedule on file with the Public Service Commission; etc.

North Carolina HB 255 – Regulate parking at EV Charging Stations

New Jersey A 2294 - Establishes mortgage payment relief and foreclosure protection for certain homeowners impacted by the remnants of Hurricane Ida.
